INTRODUCTION

The foregoing recreational plan is developed for Interior Township, Michigan. Our township is in the southern half of Ontonagon County on the western side of the Upper Peninsula. We are contiguous with Haight Township to the West, Stannard Township to the North and West while Watersmeet Township and Gogebic County border Interior Township to the South. On our east side, we border Duncan Township, Houghton County.

The Recreation and Natural Resource Conservation Plan which is developed herein by the Recreation Plan Task Force of the Interior Township Planning Commission focuses on all aspects of recreation within the Township. The plan considers current Township-owned properties and proposed property acquisitions.

Part 1: COMMUNITY DESCRIPTION

Interior Township is located along major Highway M-28, 11 miles east of major highway US-45 and 21 miles north of major highway US-2. The township is located in the south end of Ontonagon County and borders Houghton County on the east side. The unincorporated village of Trout Creek is the hub of Interior Township. The summer temperatures range from a high of 80 degrees to a low of 55 degrees while our winter season temperature range from a normal high of 20 degrees to a low of 1 degree. Average snowfall in the winter season is 90 inches.

Trout Creek is a small rural community with its own municipal water and sewage disposal systems. Our water tower was updated with necessary maintenance in 2020. Trout Creek and the outlying areas of Interior Township have a history in farming, logging and sawmill operations and mining. The mines and sawmill operations have long vanished from our township. Farming is active and logging remains an important aspect of the community.

Interior Township is a part of the Ewen-Trout Creek Consolidated School District, a K-12 school system. We are within 100 miles of four distinct and highly-rated post-secondary education campuses, Northern Michigan University, Michigan Technological University, Finlandia University and the Gogebic Community College.

The population in Interior Township has declined over the past several decades. The 2020 census number indicates a flattening in the total population of the township over the past decade. Our population is aging and we are primarily made up of older residents. This shift to older-aged residents is a result of the declining local economy forcing our young people and families to move elsewhere for employment.




Part 2: ADMINISTRATIVE STRUCTURE

Interior Township is governed by an elected Board of Trustees. This Board of Trustees is the authority responsible for all administrative and operational functions of the Township. The attached organizational chart indicates the structure of Interior Township staff, employees and volunteers (Figure 2). In reviewing the organizational chart, you will see that the administrative structure of the Township includes the Supervisor, Clerk, Treasurer and two Trustees, all of which are elected positions and receive a monthly stipend. All other employee or staff positions are appointed. All employees of the Township are part-time employees.

The Board of Trustees established a Planning Commission for the Township in 1982 to advise and assist with planning and development issues. The Planning Commission is also charged with the responsibility of advising and development of the Recreation and Natural Resource Conservation Plan for the Township. The Planning Commission created the Recreation Plan Task Force and charged it with updating the Township's Recreation Plan. The Recreation Plan Task Force consists of Planning Commission representation and public citizens to provide input, ideas and recommendations on needed recreational programs and activities for the benefit of Township residents, their families, senior citizens, persons with disabilities, as well as visitors and travelers. This public citizen's committee is not limited in terms of size or number of members. Please note that members of the Planning Commission and the Recreation Plan Task Force are unpaid volunteers. The 2021-2022 Budget for the Recreation Plan is listed below. Please note that this funding is millage voted on by the residents of Interior Township.

The task force determined that specific funding for projects would be strategically part of an individual project plan of action. The task force did also make note that there was a need for the township to be prepared to fund any necessary matching funds for grants applied as well as maintenance required to maintain a project once completed.

Several public volunteer groups have been formed in the Township and County to assist with upkeep and improvement of our recreational facilities and resources. These volunteer groups provide fund-raising activities and serve our community through active participation to not only keep resources in good condition but to take full advantage of local resources. The Planning Commission also recognizes these organizations in an advisory role by including them in the process of updating the recreation plan for Interior Township. These organizations include:

Volunteerism in Interior Township is a challenge. Our younger generation has shown little interest in getting involved in the community and many drive an hour or more for work and leisure. Many of our younger generation work away from home, months at a time, making it difficult to stay connected. Interior Township is also made up of many part-time residents who have no connection to the community. As in many communities, it is the same small group that are involved and at some point, these volunteers grow older and/or get burned out. The challenge is finding the right project at the right time to pull the community together.

Our hometown school merged many years ago and the Ewen-Trout Creek Consolidated School is located in another community in our county that is 15 miles away. Our township is represented on the elected school board. Currently, there is minimal effort to connect with the school from a community perspective.

An additional resource for the township is the Ottawa National Forest (ONF). Although no ranger station is in our township, we do have two ranger stations within our county. The closest ranger station is 6 miles away in a neighboring county. The task force determined that the township should seek partnerships with the Ottawa National Forest.

Part 3: RECREATION INVENTORY

Identifying the primary recreation resources in Interior Township included those facilities currently owned and operated by the Township, the State of Michigan and private businesses. This identification of our resources was originally completed by the Regional Development Council for the 2010-2015 Recreation Plan. The task force reviewed this list and updated as needed.

The <u>Abbott-Fox Park Community Park</u> is owned and maintained by Interior Township. This recreational facility is approximately three acres located next to the Mill Pond Dam and includes a playground, open shelter, water tap, picnic area, fire rings, lighting, historic steam engine, memorial, fishing dock and beach (on pond), and flush toilets. Two DNR grants (1977 & 2011) were utilized to create the existing park.

This community park is designed and intended for use by all township residents and neighboring community residents as well as visitors and travelers. The park is conveniently located along highway M-28 and currently provides fishing opportunities, a picnic area, children's playground area, handicap-accessible restrooms and a small sheltered picnic area. The park is centered around the Mill Pond and is home to a display of an antique historical Corliss Steam Engine which was used to provide power in operating the saw mill which existed in the area many years ago. The park is currently used by residents, travelers, Community Church service, community picnic and private events such as family reunions.

<u>Accessibility assessment</u>: Park has been upgraded with paved paths to the picnic area and the fishing dock. The site was originally built with handicapped accessible restrooms.

The <u>Hazel Sliger Museum</u> is owned by the Township and operated by the Hazel Sliger Museum Committee. The museum is a extensive collection of the heritage of the area. The museum has a new 2020 roof and is currently working on raising funds for building maintenance and establishing regular hours.

<u>Accessibility assessment</u>: The museum building needs accessibility as the entrance to the building is two steps over a pretty tall threshold.

The Bond Falls recreation area is an approximate 250 acre collaboration between the State of Michigan and private ownership. The State of Michigan Scenic Site area provides accessibility to view Bond Falls to persons with disabilities. The Bond Falls recreation area spans several townships within Ontonagon County. The Interior Township portion of this area includes a flowage, campsites, boat launch and a Commons Park State Picnic area. In addition, the privately owned portion of this area provides a rustic hiking trail to view Bond Falls, a picnic area, swimming area and primitive campsites. The campsites are spread out around Bond Lake which is a part of the Hydroelectric System of the Upper Peninsula Power company (UPPCO). Bond Lake also provides fishing opportunities.

<u>Accessibility assessment</u>. The accessibility of the Bond Falls Recreation Area indicates only the State Scenic Site Area was designed to be readily accessible to persons with disabilities. None of the facilities in the privately-owned lands were designed for persons with disabilities.

<u>Agate Falls</u> area is a natural waterfall along the Middle Branch of the Ontonagon River. The falls feature a one-acre roadside park that is owned and operated by MDNR and MDOT. The park includes a Scenic Site State Accessible hiking trail to an Agate Falls viewing deck, a picnic area, and vault toilets. This park was designed primarily as a rest stop for travelers. There is a primitive walking trail to view Agate Falls from below, however, this trail is very difficult to walk and is not recommended for the elderly and is not handicapped accessible.

<u>Accessibility assessment</u>: The accessibility of the Agate Falls area is the roadside park itself with accessible toilets and picnic tables as well as a trail to viewing deck to the falls

<u>Michigan Department of Natural Resources (MDNR)</u> owns and maintains a trail on an abandoned railroad grade traveling east-west through Interior Township. This trail has heavy snowmobile and off-road vehicle (ORV) traffic as it is connected to a larger trail system throughout the western Upper Peninsula. There currently is no trailhead located within Interior Township. Ontonagon County has an ordinance for the purpose of authorizing and regulating ORVs on roads in Ontonagon County.

<u>Michigan Trails and Recreation Alliance of Land and the Environment</u>, commonly known as MI-TRALE, is an alliance of multiple trail and outdoor recreation enthusiasts.

MI-TRALE offers more than 500 miles of ATV, ORV, multi-use and horse trails in the western U.P. of Michigan. The mission of MI-TRALE is to advance the safe and responsible use of multi-use trails for both motorized and non-motorized trail recreationists, by working towards the development, designation and the interconnection of multi-use trails in the Western Upper Peninsula of Michigan.

<u>Sno Valley Riders</u> is a local membership snowmobile club that is responsible for grooming the trail through Interior Township for winter snowmobiling. The mission of the Sno Valley Riders is to stimulate and advance the general welfare and safety of snowmobiling, to serve the interests of snowmobile owners, to improve and enhance trails and to further the welfare of our community.

<u>MI-TRALE - Equestrian Division</u>, has been working over the last three years to improve signage regarding the multi-use nature of the trail. The group has also been working with the Ottawa National Forest to create an equestrian campground on Courtney Lake north of Interior Township.

<u>MI-TRALE - Paddlers Division</u>, is active in identifying paddling opportunities along the Middle Branch and the West Branch of the Ontonagon River.

<u>Current Status for all grant-assisted Parks and Recreation Facilities:</u> The upgrades to the Abbot Fox Park were completed with a MNRTF grant along with the support of Interior Township, Park Improvement Group, Pond Fest Committee, donations and volunteers. Interior Township plans to upgrade/maintain the cement base as well as paint the steam engine located in the park in 2022. See figure 5 for a picture of the plague regarding the history of the steam engine.

Part 4: RESOURCE INVENTORY

Township owned property, 27 Acre parcel South of Mill Pond Park.

<u>Township owned property</u>, Section 12 T47N R38W Lot 1, Block 5 of Supervisors Plat No 1. This vacant lot is approximately nine acres of undeveloped land that borders Trout Creek. Owned by the township, the 2010-2015 recreation plan designated the creation of a Backwater Recreation Area Walking trail & foot bridge

<u>Township owned property</u>, along M-28 this 1.75 acres was purchased by the township for future signage along M-28.

<u>Trout Creek Cemetery</u> is owned and maintained by Interior Township. Memorial Day activities are held each year in cooperation with the local American Legion, Post 494 and the 494 Supporters.

<u>Agate Cemetery</u> is owned and maintained by Interior Township. Memorial Day activities are held each year in cooperation with the local American Legion, Post 494 and the 494 Supporters.

<u>Township owned property</u>, South $\frac{1}{2}$ of Lots 1 and 2, Block 1 of Plat of Josephine. The former surplus store is on this property.

<u>Township owned property</u>, North ½ of Lots 1 and 2, Block 1 of Plat of Josephine. Currently a vacant lot that is just north of the former surplus store along Division Street.

<u>Township owned property</u>, Small parcel along Old M-28, assumed that this parcel is the location of former gas tanks.

<u>Township owned property</u>, Small Parcel along Old M-28, combination of three smaller parcels, located roughly on the South side of Old M-28 where Loop Road would extend to if it did extend. Thought to be the location of the former railroad refueling station.

Part 5: DESCRIPTION OF THE PLANNING PROCESS

The Interior Township Planning Commission created the Recreation Plan Task Force at its December 2021 meeting. The Recreation Plan Task Force was charged with seeking public opinion and updating the Township Recreation and Natural Resource Conservation Plan that expired in December 2021. One member of the Planning Commission volunteered to be on the Recreation Plan Task Force. The Planning Commission had started the process of updating the Recreation and Natural Resource Conservation Plan earlier in 2021, ran into timing issues and made the decision to establish a short term task force to complete the plan.

The Recreation Plan Task Force has four members, one representative from the Planning Commission and three community at large members. All members of the Task Force own Interior Township property and live here year-round. Collectively, the task force brings expertise from the following perspectives: farming, forestry, wildfire firefighting, homesteading, county employee, construction/trades, hospitality, recreation and real estate. One member of the task force is a lifelong resident, another has been visiting relatives since he was 10 months old and now a permanent resident for the past nine years. Another member recently moved into the area and the other has been here for the past 7 years. Please note that three of the task force members are retired with one task force member, a stay at home Dad. Geographically, three members live outside of the unincorporated Village of Trout Creek and one lives in Trout Creek.

The Planning Commission began the task of updating/completing a Recreation and Natural Resource Conservation Plann for approval in 2022 on March 11, 2021. At that meeting the decision was made that the existing recreation plan was still relevant. The Planning Commission made the decision to focus on seeking public comment and opinion which would drive updates to the Recreation and Natural Resource Conservation Plan. Recreation and Natural Resource Conservation Plan discussions were part of two Planning Commission meetings which were held May 20, 2021 and August 5, 2021 discussing the thoughts generated during public input meetings for the previous recreation plan. We updated thoughts based upon the current situation. To be honest, our challenges, wants and needs remain the same, to include the list below.

Three work sessions were held specifically for the Recreation and Natural Resource Conservation Plan. The focus of the June 11, 2021 work session was to finalize the survey to be distributed seeking public opinion/comment on the 2022-2026 Recreation and Natural Resource Conservation Plan. The Planning Commission approved the updated survey to be distributed. A copy of the survey is included as Figure 3.

The survey was posted, available to residents and the general public, beginning July 1, 2021 through August 1, 2021. Availability of the survey was included in the township newsletter distributed with the July, 2021 tax bills, posted in the Interior Township Hall and the Trout Creek Post Office. Additionally, the survey was hand distributed to approximately 50 residents/guests/community members who attended the July 25, 2021 Holy Hootenanny sponsored by the Calvary Temple Assembly of God Church. This event attracts many local residents and visitors, notedly from Marquette, Ironwood and Wisconsin in addition to Interior Township and Ontonagon County to name a few.

The work sessions on September 9, 2021 and October 7, 2021 focused on discussion as a result of the survey data collected. Our response to the survey was disappointing, resulting in 10 surveys returned. Survey results are listed below.

If we compare the survey results to the survey completed for the 2016-2021 Recreation Plan, answers to the current survey complemented the support that we saw for projects back in 2015, except we didn't have favorable support for a blacktopped multi-purpose sports area, although we still received positive support for an in-town park.

The Planning Commission held a meeting on December 16, 2021 to appoint a Recreation Plan Task Force. The Recreation Plan Task Force were each given copies of the 2016-2021 Recreation Plan and a working draft of the updated Recreation and

Natural Resource Conservation Plan by the Planning Commission. The Task Force met on January 8, 2022 to discuss the recreation plan with a focus on Part 7: Goals and Objectives and Part 8: Action Program. An updated draft of the plan was reviewed by the Task Force prior to a joint meeting on January 10th between the Planning Commission and the Township Board. The document was provided electronically to those with means and hard copies for review of the Recreation Plan. The working Draft was also reposted at both Township Hall and the Trout Creek Post Office.






Figure 11: Picture of Steam Engine Signage at Abbot Fox Park

Part 6: DESCRIPTION OF THE PUBLIC INPUT PROCESS

Public Input was an important part of the process for the updating the Interior Township Recreation Plan. The Planning Commission and members of the Recreation Plan Task Force actively shared the recreation plan action program and welcomed comments from individual community members.

The Planning Commission and the Recreation Plan Task Force members were given and reviewed the DNR guidelines for the Development of Community Park, Recreation, Open Space and Greenway Plans and created the following plan of action for updating the Recreation Plan for Interior Township. The action plan proposed a public meeting after a 30 day posting of a Recreation and Natural Resource Conservation Plan Draft. Saturday, January 22, 2022, beginning at 10:00am was chosen to ensure all residents, out of area property owners and interested parties could provide input. As part of the posting, we offered to provide electronic copies of the draft plan to interested parties.

A draft copy was shared with the Planning Commission at its December 16, 2021 meeting. As DNR guidelines require a 30-day review period, the task force posted the Recreation and Natural Resource Conservation Plan DRAFT at Township Hall and the Trout Creek Post Office as of December 17, 2021. The Task Force decided to put in a public notice in the Ontonagon Herald after the first of the year in the January 12th weekly edition so that it did not get lost in holiday hustle and bustle.

Once the 2022-2026 Recreation and Natural Resource Conservation Plan was adopted by the Planning Commission, the Recreation and Natural Resource Conservation Plan was sent to the Interior Township Board for the creation of an adopting resolution at its January 24, 2022 meeting. The guidelines do call for a copy of the adopted plan to be sent to Ontonagon County and Regional Planning (Western Upper Peninsula Planning Economic (no approval needed, for their files). (The 2022-2026 Recreation and Natural Resource Conservation Plan for Interior Township could then be submitted to DNR in early 2022.)

Part 7: GOALS AND OBJECTIVES

- 1. Seek and consider all public input in developing a sound and sensible Recreation and Natural Resource Conservation Plan. Increase specific outreach so response truly dictates wants/needs.
- 2. Provide opportunities that sufficiently meet the recreational needs of township residents (full and part-time), as well as visitors and travelers.
- 3. Promote community awareness of all recreational opportunities
- 4. Provide diverse recreational opportunities to satisfy all age groups and levels of ability with attention to accessibility while minimizing environmental impacts and being cost effective.

Part 8. ACTION PROGRAM

Discussion was focused on what our priorities should be to our community. One of the challenges of this plan is that we included more action items than what we would ever be able to accomplish in the next five years. The task force felt that we should include all five action items as our interest is in advancing each of these items in some way over the next five years.

The task force acknowledged the Abbot Fox Community Park as the beacon to our community for residents, travelers and visitors. For many of our travelers and visitors it is their introduction to our community whether a quick stop, lunch or attending an event at the park. For residents, the park does offer much but is also in a location that is not conducive to higher traffic by community members. The task force decided that our focus must first be on what is needed and wanted by the community taking into account our opportunities to showcase our community to travelers and visitors.

Our next step was to look at the long range opportunities for our community and not only identify those that fit with the culture and heritage of our Township, but to prioritize them in relation to resident opinion and practicality. The Recreation PlanTask Force focused on specific projects that move us forward toward our long-term objectives.

Specific community realities include age of population, funding sources as well as the rural environment. In considering the age of our residents, we are challenged to provide recreational pursuits to attract and keep young families as well as appeal to the older population. Accessibility is a must for all pursuits as this area is a haven for retirees.

The Planning Commission and the Recreation Plan Task Force have worked diligently to develop a recreation plan that reflects the interest of our residents from a creativity and environmental theme taking into considerations the realities of our community. Our current research and community input confirmed that updating the 2016-2021 Recreation Plan was relevant and appropriate. Many opinions have been expressed and ideas presented. As a result, our collaborative recreation plan reflects a sensible, realistic, cost effective and attainable plan.
